# Ethical Issues HIV/AIDS: A Decision-Making Model June 8, 2018 9 AM to 4:30 PM

Ethical issues and decision-making treatment issues are difficult but especially those related to providing mental health services to clients who have HIV disease. These cases in particular are complex and challenging. Often practitioners have no clear policy, legal or ethical directives to guide them in responding to ethical dilemmas. Literature on the issue over the past decade reflects divergent and often conflicting opinions regarding such issues as confidentiality, duty to protect, and suicide.

Practitioners are in dire need of guidance and direction. Professional development seminars underscore that there is seldom a single, correct course of action for practitioners. This curriculum is specifically designed for mental health service providers to teach them one process for arriving at sound, ethical decision-making when dealing with HIV-related issues in practice. It is important to emphasize the curriculum does not provide a set of correct answers because society does not have clear answers to many ethical dilemmas. While there are other ethical decision-making models, this approach was chosen for its clarity and ease of application to clinical cases related to HIV or ethical decision-making processes in general.

## Gregory Sarlo, Psy.D. (he/him/his)

Dr. Sarlo, a Licensed Clinical Psychologist, is the Founder, Clinical Director, and Director of Training of *Psychological Consultations*. A graduate of <u>The Adler School of Professional</u> **Psychology**, Dr. Sarlo has worked with Lesbian, Gay, Bisexual, Transgendered, and Questioning



(LGBTQ) communities since 1987. He served as the President of the <u>Illinois Psychological Association</u> (IPA) from 2008-2009 and again from 2010-2011. Dr. Sarlo is a longtime member of the <u>American</u> <u>Psychological Association</u> (APA) and their <u>Division 44</u>, the Society for the Psychological Study of Lesbian, Gay, Bisexual and Transgender Issues. He is currently serving on the Executive Committee of Division 44 as their Outreach Coordinator. In 2012, Dr. Sarlo was appointed Senior Faculty of APA's HIV Office for Psychology Education (HOPE) Program. The program endeavors to enhance psychologists' ability to competently and compassionately respond to people infected and/or affected by HIV.

Dr. Sarlo provides clinical supervision and training for graduate students and is working actively to help find ways to place Psychology Graduate Interns within Illinois; as president of the IPA Dr. Sarlo played a key role in starting <u>IPAPIC</u>, a consortium of internship training facilities; he current serves as the Founder and Clinical Director of IPAPIC. He also works with the HIV impacted community conducting studies and neuropsychological testing. In addition Dr. Sarlo is one of the founding members of <u>The Association of Chicagoland Externship</u> and Practicum Training Sites (ACEPT), and founding past President. He continues to focus on the areas of diversity and forensics in the profession of Clinical Psychology.

In 2014 Dr. Sarlo was honored by by the Illinois Psychological Association with the *Outstanding Contribution to Student Training in Illinois* award. Dr. Sarlo frequently presents on various topics related to HIV/AIDS, Ethics, Neuropsychology, psychological testing, graduate training and various psychological and health related topics. He has presented for numerous

organizations and colleges, such IPA, APA, John Marshall School of Law, Elmhurst College, as well as The Office Of the Attorney General for the state of Illinois. In 2012 Dr. Sarlo was appointed by the Mayor of Des Plaines to the Des Plaines Library Board; in 2013 he was elected by his board peers to service is the Library Board President.

Dr. Zoline is a Licensed Clinical Psychologist with a doctorate from De Paul University.
